Konu: AB'nin Gökkuşağı Alabalık Sübvansiyon Önlemlerini Gözden Geçirme Soruşturması

Bilindiği üzere, İlgi'de kayıtlı yazımızla, Avrupa Komisyonu tarafından, 20 Eylül 2021 tarihinde ülkemiz menşeli "gökkuşağı alabalıkları" ithalatına karşı yürürlükte olan sübvansiyon önlemlerine ilişkin bir gözden geçirme soruşturmasının başlatıldığı bildirilmiştir.

Bu defa, Ticaret Bakanlığından söz konusu soruşturma ile ilgili olarak alınan yazında, Avrupa Birliği Komisyonu tarafından Ticaret Bakanlığına gönderilen ve bir örneği ekte paylaşılan 05 Ekim 2021 tarihli Nota'da soruşturmanın açılmasını müteakip Komisyon yetkilileri ile iletişime geçen üretici ihracatçı firmalarımızdan/firma gruplarından ülkemizden yapılan ithalatın % 64'ünü kapsayacak şekilde en yüksek ihracat yapan 3 firmanın örneklemeye alınmasına karar verildiği ifade edilmiş olup, bahsi geçen firmalar aşağıda sunulmuştur:

- GÜMÜŞDOĞA SU ÜRÜNLERİ ÜRETİM İHRACAT VE İTHALAT A.Ş.
- FISHARK SU ÜRÜNLERİ ÜRT. SAN. VE TİC A.Ş.
- ÖZPEKLER İNŞAAT TAAHHÜT DAY. TÜKETİM MALLARI SAN. VE TİC. LTD. ŞTİ.

In accordance with the legislation in force¹, on 20 September 2021 the European Commission initiated an anti-subsidy proceeding concerning imports of certain rainbow trout originating in Turkey.

After analysing the sampling information received from exporting producers, the European Commission has decided to limit the investigation to a reasonable number of parties by using a sample in accordance with Article 27(1) of the basic anti-subsidy Regulation.

Subject: **R749 Anti-subsidy review concerning imports of certain rainbow trout originating in Turkey**

In accordance with Article 19 of the legislation in force¹, on 20 September 2021 the European Commission initiated an anti-subsidy proceeding concerning imports of certain rainbow trout originating in Turkey.

After analysing the sampling replies received from 16 exporting producers, the Commission has decided to limit the investigation to a reasonable number of parties in accordance with Article 27(1) of basic anti-subsidy Regulation.

The Commission hereby informs interested parties of the sample of exporting producers, as specified in Section 4.2(a) of the Notice of Initiation. Pursuant to Article 27 of the basic Regulation, the selection of the sample was based on the largest representative volume of exports to the Union during the review investigation period, which can reasonably be investigated within the time available.

Based on the information available at this stage, the proposed sample accounts for 64% of the estimated total export volume to the Union from Turkey in the review investigation period.
