Subject: Request from the Ukrainian Government

Dear fellow ETPO members,

Our team at the Entrepreneurship and Export Promotion Office is continuing to help Ukrainian businesses and the Government of Ukraine in the time of Russian war against Ukraine.

Today we have an urgent request from the Ukrainian Government to purchase imported food products. We are sorry that we are writing this request on Friday evening, but unfortunately, Russian forces do not provide us with week-ends these days.

Please see the request below. We are ready to send an official letter and provide any other support you or your companies may need in case you have suppliers who could cover some of this request.

The Government of Ukraine is looking to procure:

- 10 mln packs of pasta (all types, each pack 500-1000g)
- 50 mln packs of canned meat/ or fish (each pack 100-500g) - in necessary amount of meat/fish is not available, we may consider canned beans (ready to consume)
- 20 mln of army food packs (one day ration - 3 meals) of NATO standard or UN standard

Delivery by sea to Constantza (Romania) - we will organize further shipment by rail to Ukraine.

- 10 mln packs of rice (all types, each pack 500-1000g)
- 10 mln packs of cereals (all types, each pack 500-1000g)

We are ready to pay 30% immediately and the rest 60%, when the food is loaded in the ship and custom documents, are confirmed and 10% when containers are delivered to Romania.

This is our immediate need that we would like to procure in the following 1-2 days. And deliver immediately
