Sayın Üyemiz,

Türkiye İhracatçılar Meclisinden alınan 10/05/2024 tarihli bir yazıda, Meksiko Ticaret Müşavirliği yazısına atfen, Meksika Genel İthalat ve İhracat Vergileri Kanunu kapsamında 22.04.2024 tarihli Meksika Federal Resmi Gazetesi'nde yayımlanarak yürürlüğe giren Kararname ile çelik, alüminyum, tekstil, giyim, ayakkabı, ahşap, plastik ve mamulleri, kimyasal ürünler, kağıt ve karton, seramik ürünler, cam ve mamulleri, elektrikli teçhizat, ulaşım ekipmanları, müzik aletleri ve mobilya ile ilgili 544 gümrük tarife kodunda sınıflandırılan malların ithalatında gümrük vergilerinin %5 ila %50 arasında değişen oranlarda yeniden tesis edilmesine yönelik bir düzenleme yapıldığı ifade edilmektedir.

Anılan yazıda devamla, adil piyasa koşullarının sağlanması, yerli sanayinin gelişiminin teşvik edilmesi ve iç pazarın desteklenmesi amacıyla yapılan düzenlemelere ilişkin olarak daha detaylı bilginin aşağıda yer alan internet adresinde Kararname metninde bulunduğu belirtilmektedir. Ayrıca, Meksiko Ticaret Müşavirliği tarafından İngilizce diline yapılan gayri resmi tercüme yazısı ekte yer almakta olup ilave bilgi için ilgili Ticaret Müşavirliği (meksika@ticaret.gov.tr) ile temasa geçilmesinin faydalı olacağı değerlendirilmektedir.

DECREE that modifies the Rate of the Law of General Import and Export Taxes.

**In the margin a seal with the National Coat of Arms, which says: United Mexican States.-

ANDRÉS MANUEL LÓPEZ OBRADOR, president of the Mexican United States, in the exercise of the power conferred on me by article 89, fraction I, of the Political Constitution of the Mexican United States, based on articles 131 constitutional; 31 and 34 of the Federal Public Administration Organic Act, and 2nd, 4th, fraction I, 6th. and 12 of the Foreign Trade Act, y

WHEREAS

That article 25, first paragraph, of the Political Constitution of the United Mexican States (CPEUM) establishes that "[t]he State is responsible for the stewardship of national development to guarantee that it is comprehensive and sustainable, that it strengthens the sovereignty of the Nation." and its democratic regime and that, through competitiveness, the promotion of economic growth and employment and a fairer distribution of income and wealth, allows the full exercise of freedom and dignity of individuals, groups and social classes " ;

That article 131, second paragraph, of the CPEUM confers on the Federal Executive the extraordinary power to increase, decrease or eliminate the quotas of export and import tariffs, issued by the Congress of the Union, and to create others, as well as to restrict and prohibit imports, exports and transit of products, articles and effects, when deemed urgent, in order to regulate foreign trade, the country's economy, the stability of national production or to carry out any other purpose, in benefit of the country;

That the General Agreement on Customs Tariffs and Trade, which is part of the Marrakesh Agreement establishing the World Trade Organization, whose promulgatory decree was published in the Official Gazette of the Federation (DOF) on December 30, 1994, allows the States Parties to make adjustments to their import tariffs, to the extent that these do not exceed those established in the list of concessions agreed upon within the framework of said organization;

That the "Decree establishing various Sector Promotion Programs", published in the DOF on August 2, 2002 and its subsequent modifications, aims to grant the national productive industry better conditions for the supply of inputs and machinery, as well as mechanisms to exercise greater participation in the markets, which generates competitive conditions to establish tariff conditions that allow access to the strategic inputs that national industries use in their production processes, under conditions similar to those that their competitors have in the market. abroad;

That, the National Development Plan 2019-2024, published in the DOF on July 12, 2019, establishes in its general axis " Economy " , section " Promote economic reactivation, the internal market and employment " , that one of the The central tasks of the current federal government are to promote economic reactivation and ensure that the economy grows again at acceptable rates, which requires strengthening the internal market;

That the " Decree issuing the Law on General Import and Export Taxes " , published in the DOF on June 7, 2022, establishes in its article 1. the tariff quotas of said law that attend to the classification of the merchandise, and serve to determine the general import and export taxes;

That the " Decree modifying the Rate of the Law of General Import and Export Taxes , the Decree to support the competitiveness of the terminal automotive industry and the promotion of the development of the domestic automobile market, the Decree for the Promotion of the Manufacturing, Maquiladora and Export Services Industry, the Decree establishing the general import tax for the border region and the northern border strip, the Decree of the Chetumal free zone, the Decree for the that various Sector Promotion Programs are established, the Decree that

regulates the definitive importation of used vehicles and the various ones that establish quota tariffs " , published in the DOF on November 18, 2022, modified various instruments to update them in accordance with the new rate of the General Import and Export Tax Law (TIGIE), published in the DOF on June 7, 2022, in order to provide legal certainty to foreign trade users, in which They include the tariff fractions of the steel, footwear, textile and clothing sectors, among others;

That the " Decree modifying the Rate of the Law of General Import and Export Taxes " , published in the DOF on August 15, 2023, temporarily modifies the tariffs of 392 tariff fractions of the TIGIE, related to steel, aluminum, bamboo, rubber, chemicals, oils, soap, paper, cardboard, ceramic products, glass, electrical material, musical instruments and furniture, among others, in order to provide certainty and fair market conditions to all sectors that face situations of vulnerability, to allow the recovery of the national industry, promote its development and support the internal market;

That from 2018 to 2023, the national production chains related to the products indicated in the previous paragraph have been affected by the slowdown in economic growth caused by geopolitical and commercial conflicts, which affects their competitiveness in the national and international market, as well as the continued employment of thousands of people, so Mexican industries require a period of adjustment for their recovery;

That the federal government has the obligation to implement the necessary mechanisms that generate stability in the national industry sectors and that allow the elimination of distortions in trade, to safeguard the balance of the global market in accordance with international law and the international commitments acquired by our country;

That due to the growing implementation of new commercial models worldwide, such as the case of relocation (*nearshoring*), which aims to bring the production of goods closer to the territories of consumption, it is necessary to implement concrete actions that allow a balanced interaction of the market to avoid economic distortions that could affect the relocation of productive sectors considered strategic for the country, as well as the attraction of new companies and industries with high added value;

That, derived from the above, it is advisable to establish temporary tariffs, of between 5% to 50%, on the import of goods classified in 544 tariff fractions related to steel, aluminum, textiles, clothing, footwear, wood, plastic and their manufactures, chemical products, paper and cardboard, ceramic products, glass and its manufactures, electrical equipment, transportation equipment, musical instruments, furniture, among others, in order to provide certainty and fair market conditions to the sectors of the national industry that face situations of vulnerability, derived from practices that alter and affect international trade and, thus, promote the development of the national industry and support the internal market;

That the proposed measure is in accordance with international law, since the importation of goods originating from the countries with which Mexico has concluded a trade treaty, if the requirements established therein are met, will be carried out under preferential tariff treatment. of originating goods provided for in the corresponding international instrument;

That, in order to avoid affecting the production chains and to maintain competitiveness in the most sensitive industrial sectors such as electrical, electronic, automotive and auto parts, it is necessary to maintain, for the same period of validity of the tariffs provided for in this decree, the tariff benefit of the Sector Promotion Programs applicable to tariff fractions of various steel products, and

That, in accordance with the provisions of the Foreign Trade Law, the tariff measures referred to in this decree have the opinion of the Foreign Trade Commission, I have seen fit to issue the following

DECREE

Unique Item. The tariffs of the tariff sections of the Tariff of the Law of General Import and Export Taxes, published in the Official Gazette of the Federation on June 7, 2022 and its subsequent modifications, are temporarily modified , which are indicated below:

III. In the programs of the automotive and auto parts industries, tariff items 7208.26.01, 7208.27.01, 7209.16.01, 7209.17.01, 7211.29.99, 7225.30.91 and 7225.40.91.

DECREE that modifies the Rate of the Law of General Import and Export Taxes.

ANDRÉS MANUEL LÓPEZ OBRADOR, president of the Mexican United States, in the exercise of the power conferred on me by article 89, fraction I, of the Political Constitution of the Mexican United States, based on articles 131 constitutional; 31 and 34 of the Federal Public Administration Organic Act, and 2nd, 4th, fraction I, 6th. and 12 of the Foreign Trade Act, y

WHEREAS

That article 25, first paragraph, of the Political Constitution of the United Mexican States (CPEUM) establishes that "[t]he State is responsible for the stewardship of national development to guarantee that it is comprehensive and sustainable, that it strengthens the sovereignty of the Nation." and its democratic regime and that, through competitiveness, the promotion of economic growth and employment and a fairer distribution of income and wealth, allows the full exercise of freedom and dignity of individuals, groups and social classes " ;

That article 131, second paragraph, of the CPEUM confers on the Federal Executive the extraordinary power to increase, decrease or eliminate the quotas of export and import tariffs, issued by the Congress of the Union, and to create others, as well as to restrict and prohibit imports, exports and transit of products, articles and effects, when deemed urgent, in order to regulate foreign trade, the country's economy, the stability of national production or to carry out any other purpose, in benefit of the country;

That the General Agreement on Customs Tariffs and Trade, which is part of the Marrakesh Agreement establishing the World Trade Organization, whose promulgatory decree was published in the Official Gazette of the Federation (DOF) on December 30, 1994, allows the States Parties to make adjustments to their import tariffs, to the extent that these do not exceed those established in the list of concessions agreed upon within the framework of said organization;

That the "Decree establishing various Sector Promotion Programs", published in the DOF on August 2, 2002 and its subsequent modifications, aims to grant the national productive industry better conditions for the supply of inputs and machinery, as well as mechanisms to exercise greater participation in the markets, which generates competitive conditions to establish tariff conditions that allow access to the strategic inputs that national industries use in their production processes, under conditions similar to those that their competitors have in the market. abroad;

That, the National Development Plan 2019-2024, published in the DOF on July 12, 2019, establishes in its general axis " Economy " , section " Promote economic reactivation, the internal market and employment " , that one of the The central tasks of the current federal government are to promote economic reactivation and ensure that the economy grows again at acceptable rates, which requires strengthening the internal market;

That the " Decree issuing the Law on General Import and Export Taxes " , published in the DOF on June 7, 2022, establishes in its article 1. the tariff quotas of said law that attend to the classification of the merchandise, and serve to determine the general import and export taxes;

That the " Decree modifying the Rate of the Law of General Import and Export Taxes , the Decree to support the competitiveness of the terminal automotive industry and the promotion of the development of the domestic automobile market, the Decree for the Promotion of the Manufacturing, Maquiladora and Export Services Industry, the Decree establishing the general import tax for the border region and the northern border strip, the Decree of the Chetumal free zone, the Decree for the that various Sector Promotion Programs are established, the Decree that

regulates the definitive importation of used vehicles and the various ones that establish quota tariffs " , published in the DOF on November 18, 2022, modified various instruments to update them in accordance with the new rate of the General Import and Export Tax Law (TIGIE), published in the DOF on June 7, 2022, in order to provide legal certainty to foreign trade users, in which They include the tariff fractions of the steel, footwear, textile and clothing sectors, among others;

That the " Decree modifying the Rate of the Law of General Import and Export Taxes " , published in the DOF on August 15, 2023, temporarily modifies the tariffs of 392 tariff fractions of the TIGIE, related to steel, aluminum, bamboo, rubber, chemicals, oils, soap, paper, cardboard, ceramic products, glass, electrical material, musical instruments and furniture, among others, in order to provide certainty and fair market conditions to all sectors that face situations of vulnerability, to allow the recovery of the national industry, promote its development and support the internal market;

That from 2018 to 2023, the national production chains related to the products indicated in the previous paragraph have been affected by the slowdown in economic growth caused by geopolitical and commercial conflicts, which affects their competitiveness in the national and international market, as well as the continued employment of thousands of people, so Mexican industries require a period of adjustment for their recovery;

That the federal government has the obligation to implement the necessary mechanisms that generate stability in the national industry sectors and that allow the elimination of distortions in trade, to safeguard the balance of the global market in accordance with international law and the international commitments acquired by our country;

That due to the growing implementation of new commercial models worldwide, such as the case of relocation (*nearshoring*), which aims to bring the production of goods closer to the territories of consumption, it is necessary to implement concrete actions that allow a balanced interaction of the market to avoid economic distortions that could affect the relocation of productive sectors considered strategic for the country, as well as the attraction of new companies and industries with high added value;

That, derived from the above, it is advisable to establish temporary tariffs, of between 5% to 50%, on the import of goods classified in 544 tariff fractions related to steel, aluminum, textiles, clothing, footwear, wood, plastic and their manufactures, chemical products, paper and cardboard, ceramic products, glass and its manufactures, electrical equipment, transportation equipment, musical instruments, furniture, among others, in order to provide certainty and fair market conditions to the sectors of the national industry that face situations of vulnerability, derived from practices that alter and affect international trade and, thus, promote the development of the national industry and support the internal market;

That the proposed measure is in accordance with international law, since the importation of goods originating from the countries with which Mexico has concluded a trade treaty, if the requirements established therein are met, will be carried out under preferential tariff treatment. of originating goods provided for in the corresponding international instrument;

That, in order to avoid affecting the production chains and to maintain competitiveness in the most sensitive industrial sectors such as electrical, electronic, automotive and auto parts, it is necessary to maintain, for the same period of validity of the tariffs provided for in this decree, the tariff benefit of the Sector Promotion Programs applicable to tariff fractions of various steel products, and

That, in accordance with the provisions of the Foreign Trade Law, the tariff measures referred to in this decree have the opinion of the Foreign Trade Commission, I have seen fit to issue the following

TRANSIENTS

First. This decree comes into force the day after its publication in the Official Gazette of the Federation. Its validity is two years from its entry into force.

Second. The " Decree modifying the Rate of the Law of General Import and Export Taxes " published in the Official Gazette of the Federation on August 15, 2023 is repealed .

Third. For the purposes of the " Decree establishing various Sector Promotion Programs " , published in the Official Gazette of the Federation on August 2, 2002 and its subsequent modifications; From the entry into force of this ordinance and until the end of its validity, the programs referred to in sections I, II and XIX of article 5 of said decree are including the following tariff sections:

I. In the electrical industry program, tariff items 7208.39.01, 7208.51.04 and 7211.29.99;

II. In the electronic industry program, tariff section 7225.19.99, solely for the purposes of section II, paragraph b), of article 5 of the decree referred to in this transitional, and

III. In the programs of the automotive and auto parts industries, tariff items 7208.26.01, 7208.27.01, 7209.16.01, 7209.17.01, 7211.29.99, 7225.30.91 and 7225.40.91.
