# Government Support



In order to develop tourism infrastructure, attract investment, create favorable conditions for the private sector and increase employment, from 2024 to 2026, the State Budget of the Republic of Uzbekistan will compensate investors for the costs of construction and equipping new hotels:

- 3 stars – 40 million soums for each room;
- 4 and 5 stars – 65 million for each room



Also, the state budget of the Republic of Uzbekistan partially covers the costs of royalties to attract famous and prestigious hotel brands:

- 3 stars – US\$200 equivalent per year for each room;
- 4 stars – US\$400 equivalent per year for each room;
- 5 stars – US\$600 equivalent per year for each room.

The goal of the project is to increase the tourist attractiveness of the country, the quality of services in the hospitality industry.

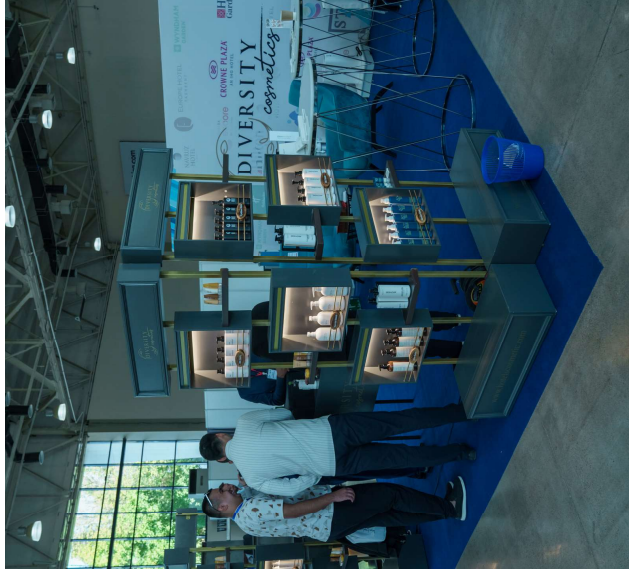
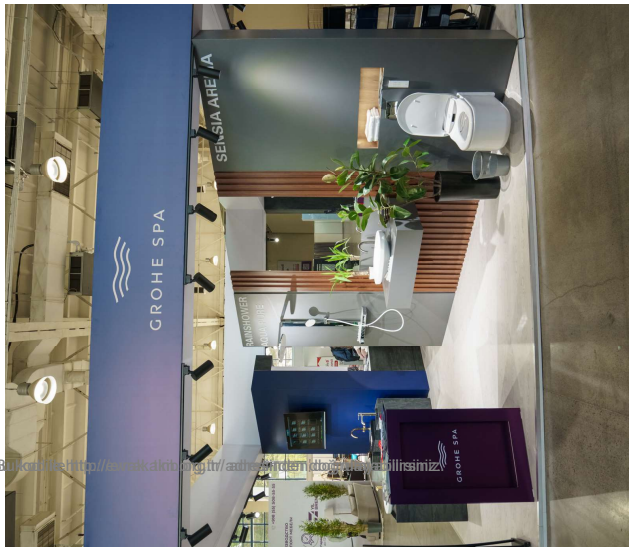
