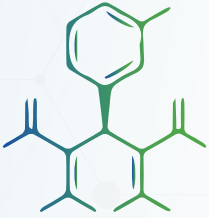

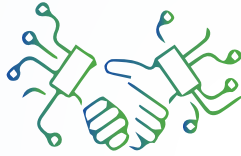

Overview:

- CIS countries are largely **import-dependent** for pharmaceuticals, especially generic formulations and APIs.
- Uzbekistan is leading regional pharmaceutical sector development with strong **government backing and incentives**.

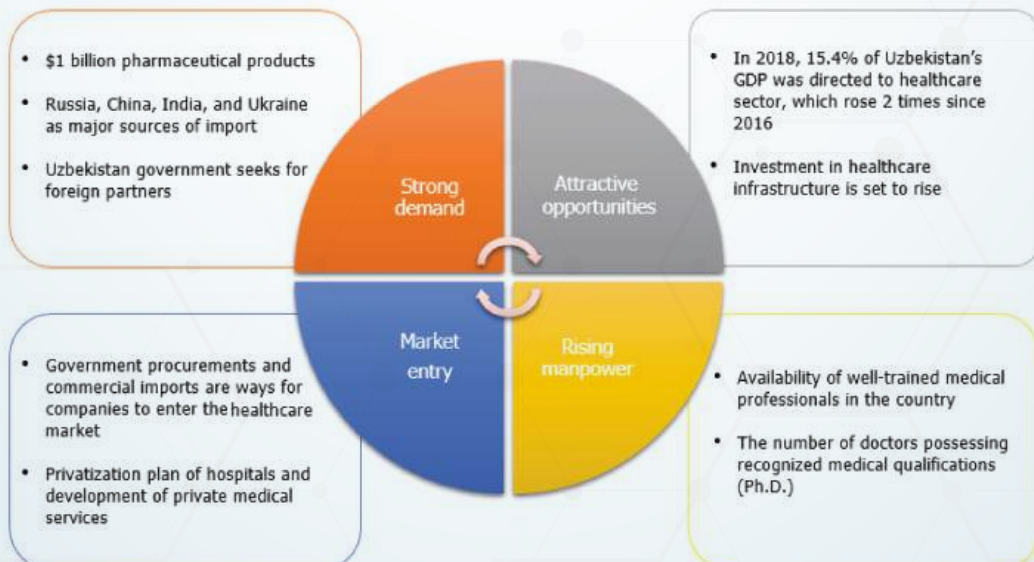

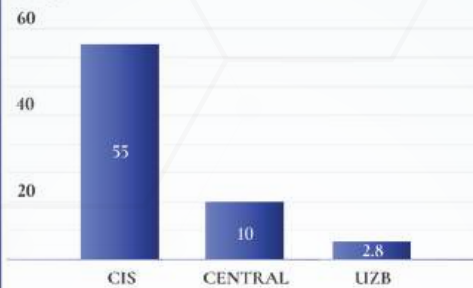

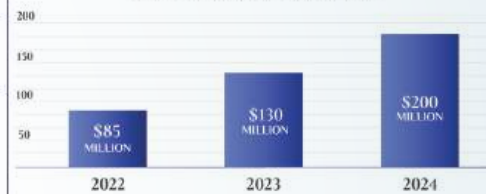
