Sayın Üyemiz,

T.C. Ticaret Bakanlığı İthalat Genel Müdürlüğünden alınan bir yazıda; Birleşik Krallık tarafından Dünya Ticaret Örgütü (DTÖ) Korunma Önlemleri Komitesi'ne yapılan ve 5 Ağustos 2026 tarihinde DTÖ tarafından yayımlanan G/SG/N/6/GBR/2 sayılı bildirimde göre; anılan ülke tarafından, Birleşik Krallık Gümrük Tarife Cetveli'ne göre 3907.61. 00, 3907.69.00 gümrük tarife pozisyonlu “Poly(ethylene Terephthalate)” ürünlerinin ithalatına yönelik olarak bir korunma önlemi (*safeguard measure*) soruşturması başlatıldığı ve mezkûr bildirimin bir örneğinin ekte yer aldığı bildirilmektedir.

Söz konusu bildirimin incelenmesinden de görülebileceği üzere soruşturmaya taraf olmak isteyen tarafların taleplerini ve soruşturma konusunda görüşlerini 19 Ağustos 2026 tarihine kadar soruşturma otoritesine iletilmesi gerektiği bildirilmektedir.

Korunma önlemi soruşturmaları, DTÖ'ye üye ülkelerin GATT 1994'ün XIX. Maddesi ve DTÖ Korunma Önlemleri Anlaşması'nın ilgili hükümlerinden kaynaklanan hakları doğrultusunda; öngörülmemen gelişmelerden kaynaklanan mutlak ya da yerli üretime kıyasla nisbi ithalat artışının, yerli endüstriye zarar verdiği veya zarar tehdidi oluşturduğu iddiası ile açılmakta olup soruşturma sonucunda menşee ülkesi ayrımı yapılmaksızın tüm ithalata karşı bir korunma önlemi uygulanabilmektedir.

**NOTIFICATION UNDER ARTICLE 12.1(A) OF THE AGREEMENT
ON SAFEGUARDS ON INITIATION OF AN INVESTIGATION
AND THE REASONS FOR IT**

UNITED KINGDOM

Poly(ethylene Terephthalate)

The following communication, dated and received on 5 August 2026, is being circulated at the request of the delegation of the United Kingdom.

Pursuant to Article 12.1(a) of the Agreement on Safeguards, the United Kingdom (UK) notifies the initiation of a safeguard investigation by the Trade Remedies Authority ("TRA"), the UK's competent authority, relating to the imports of Poly(ethylene Terephthalate) ("PET").

The investigation will consider whether it would be appropriate to apply a safeguard measure on the imports of PET into the UK.

1. Specify the date when the investigation was initiated

The TRA initiated the investigation on 5 August 2026.

2. Provide the precise description of the product(s) involved

The goods subject to investigation are:

Poly(ethylene Terephthalate) resin, whether virgin produced poly(ethylene terephthalate) ("vPET") having a viscosity number of 74 ml/g or higher or recycled poly(ethylene terephthalate) ("rPET") of the same viscosity range.

The goods concerned are subject to the following commodity codes:

- 39 07 61 00
- 39 07 69 00

3. Provide the reasons for the initiation of the investigation:**(i) Was the investigation initiated pursuant to a petition from the domestic industry?**

The TRA is initiating this investigation after receiving an application from ALPEK Polyester Limited ('the Applicant'), alleging that the goods concerned have been imported into the UK in increased quantities which has caused, and is causing, serious injury to UK PET producers.

(ii) Evidence on the basis of which the investigation was initiated.Increased import quantities:

The Applicant provided evidence to the TRA that there had been clear and significant increases to import volumes of the goods concerned to the UK. The TRA has reviewed trade data at a 6-digit commodity code level, which appear to support this claim.

The Applicant also gave domestic production and sales data, from 2021-2025, to the TRA. The data demonstrated a significant increase in the quantity of imports of the goods concerned relative to total UK domestic production.

Significant increase and unforeseen developments:

The Applicant supplied evidence to the TRA that the increase in quantities of imports was significant, and the increase in imports of the goods concerned was a result of unforeseen developments, citing several factors including but not limited to:

- Russia's war in Ukraine;
- Accelerated increases in excess global PET capacity;
- Fundamental changes to the PET resin market in Asia.

The TRA reviewed UK customs trade data, from 2021-2025, which appeared to support the Applicant's allegations of a significant increase in the rate and volume of imports of the goods concerned.

Serious injury:

The Applicant provided evidence that the increase in the quantity of imports of the goods concerned have caused, and are causing, serious injury to UK producer. The Applicant has supplied data which indicates the following:

- The UK market has been impacted by a significant increase in the quantity of imports of the goods concerned, and this is reflected in the changing market share held by overseas exporters;
- Negative changes to the UK producers' economic circumstances, including
 - Decline in domestic sales;
 - Decline in productivity;
 - Decline in production;
 - Reduction in capacity utilisation;
 - Deterioration in financial performance, including prices and profitability; and
 - Decline in employment levels.
- The Applicant has also claimed that the increased quantities of imports are threatening to cause serious injury, through the effect of increased global PET capacity.

5. Provide the deadlines and procedures for importers, exporters and other interested parties to present evidence and their views, including (i) deadlines and procedures for Members and exporters to identify themselves as interested parties, if so required, to participate in the proceeding, and (ii) the date of an intended public hearing as provided for in Article 3.1
